## **RESPONSIBILITIES OF THE BOARD EXECUTIVE**

#### **POLICY NUMBER: B7**

### A. CHAIRMAN

The Chairman shall:

- a. Preside at all official meetings, preserve order and enforce the by-laws and policies of the Board.

- c. Be authorized to call special meetings of the Board.
- d. Be the spokesperson and representative of the Board for any matter dealt with by Board resolution, including contracts and partnership agreements.
- e. Represent the Board at public functions.
- f. Maintain regular liaison with the Library Manager and Career Resource Centre Coordinator.
- g. Approve personnel records.
- h. The Chair will be one of the signing authorities for the Board.
- i. In the absence of the Treasurer, act in the capacity of the Treasurer.

## **B. VICE-CHAIRMAN**

The Vice-Chairperson shall:

- a. In the absence of the Chairman act in the capacity of the Chairman.
- b. Undertake to do specific assignments for the Chairman.
- c. In the absence of the Secretary, act in the capacity of the Secretary.
- d. Will be one of the signing authorities for the Board.

## C. SECRETARY

The Secretary shall:

- a. Act as Secretary for all Board Meetings, and prepare all minutes.
- b. Maintain permanent records as required.
- c. Coordinate destruction of obsolete records as required.

## D. TREASURER

The Treasurer shall:

- a. Work with Library Staff and coordinate preparation of the Annual Budget.
- b. The Treasurer will review all financial reports and statements prepared by the Library Manager and Career Resource Centre Coordinator and report to the Board at regularly scheduled Board meetings.
